2008 Trail Conference

The 2008 Kansas Health Summit: Built Environment and the Outdoors is scheduled for October 6 & 7 at the Hyatt Regency in downtown Wichita. The conference will focus on trail issues and the health benefits of outdoor activity.

A free presentation by Richard Louv, author of the *Last Child in the Woods: Saving Our Children From Nature-Deficit Disorder*, will be held at Century II on the evening of October 6. His book brings together a new and growing body of research indicating that direct exposure to nature is essential for healthy childhood development and for the physical and emotional health of children and adults. The presentation will be open to the public and a book signing will follow.

Among the various topics to be discussed at the conference are:

- Shared vs. Single Use Trails: When is Each Appropriate?
- The State of Outdoor Recreation in Kansas
- Single Track Trail Assessment
- Pathway and Stream Corridor Planning Projects

- Keeping the Great Outdoors Great

New Trail Projects

The Kansas Trails Council has submitted a request for a recreational trail grant to fund a trail project at Ford County Lake, near Dodge City. The project, which is a partnership with the KTC and the Southwest Kansas Mountain Bike Club, will involve the redesign and expansion of the trails to accommodate increasing trail usage and add better trail access near existing restroom and parking facilities.

The KTC is also a partner in a proposed recreational trail grant project at Fall River Lake submitted by the Kansas Single Track Society. The KTC has been working with the KSS on a trail on the northeast side of Fall River Lake for the past two years. This six-mile trail should be completed by year-end. The new project in the Badger Creek area will add six to ten miles of new trails. The Badger Creek loop will wind through a mature oak forest and large limestone bluffs and boulders (see photo).

Board Meeting Minutes

3rd Quarter Board meeting – August 17, 2008

Call to order

• The KTC Board met at Martinelli's Little Italy Restaurant, Salina, Kansas.

• Board members present were Lyle Riedy, President; Bob Nicholson, Vice President; Mike Goodwin, Treasurer; Susan Haynes, Secretary; John Haynes; Olivia Huddleston; Doug Palen; Neil Taylor; and Jim Thomas; Guests present were Mary Hanson and John Wentling.

• The meeting was called to order at 1:01 PM by Lyle Riedy, President.

• **Approval of Minutes:** Mike moved and Olivia seconded a motion to approve the minutes. Motion passed.

Executive Committee Reports and Business Items

• **Treasurer's Report:** Mike reported that the Sanders Mound and Wilson Lake grant projects are completed, with a little over \$2,200 in reimbursement still to be received from the Wilson Lake project. The Statewide Trail Guide project is in the graphic design process and will go to press in the next month or two. Reports on accounts, investments and Friends of the Trail contributions were presented. Investments are about the same as the past quarter.

• **Membership Report:** Nancy Goodwin, Membership Chair, reported that six new members have joined KTC since the last meeting, bringing the total to about 100.

• **MOAs:** Lyle led a discussion on the progress of obtaining MOAs from each park/land manager via the trail coordinators. The secretary will set up a spread sheet to keep track of this and will receive copies of the MOAs as they become available for record keeping purposes. Lyle will contact any trail coordinators that still need to complete the process.

New Business

• **Presentation on shared trail use:** Mary Hanson, National Park Service, Midwest Region, explained her position as a resource, facilitator, and mediator in the pursuit of shared use trails. The Midwest Region covers the rivers, trails and conservation systems of thirteen states. Kansas is limited in the amount of public lands available and access to areas, especially to waterways, which makes lengthy trail development difficult. Mary cited education, etiquette, training, and pooling of resources as key ingredients in the success of shared use trails. Two shared use projects are in development in Kansas, one near Marysville and another at Elk City Lake.

• Smoky Valley Ranch contract proposal: Phase I of this proposal would contract KTC to develop public and private hiking trails on The Nature Conservancy's Smoky Valley Ranch in Logan County, Kansas. TNC would pay expenses and a technical service fee to KTC for trail development. TNC will maintain the trails. The West Side Public Trail will be for hiking only at this point and feature scenic vistas, historical features and key ecological and geological attributes. The Ranch House Guest Private Trail will be a minimal-development, minimal-maintenance trail to afford ranch guests access to the river corridor and grassland and shrub land areas nearby. Bob moved and Olivia seconded a motion to proceed with Phase I of The Nature Conservancy Smoky Valley Ranch contract proposal. Motion carried.

• Website and Mapping proposal: After discussion it was decided to decline to proceed with this project at this time.

• **Trail Equipment purchases:** After discussion it was decided to table any purchases at this time and to work on putting a package together during the next quarter.

• Land Manager of the Year: Bob presented the idea of an award for land managers and discussion followed. Bob will be the chair of the committee to further work on this.

• **Gas/mileage reimbursement for work days:** After discussion it was decided that Lyle and Mike would form a plan for reimbursement of excess expenses to present to the Board.

• Vacant Board Position: Bob moved and Neil seconded the motion to nominate John Wentling to fill the vacant Board position. The motion passed.

• **Next meeting:** 1:00-3:00 PM, November 16th, at the Free State Brewing Co. (636 Massachusetts) in Lawrence.

• John moved and Jim seconded a motion to adjourn. Motioned carried and meeting adjourned at 3:12 PM.

Clinton Lake – North Shore Trails

Much is happening this fall on the North Shore Trails. We have four Eagle Scout projects in progress involving major trail reroutes, adding a bridge and constructing more "skinnies" on the Skills Loop. Two of the projects will reroute heavily eroded sections of the first mile of the White trail. A bridge will be built upstream from a chronically wet drainage area around Mile 4.5 on the Blue trail.

Two Eagle Scout projects were completed this summer. Jon Corkins crew rerouted a ¼ mile section of the blue trail and built a new armored crossing through mud creek. Brock Norwood's project involved adding a trail around Lake Henry fishing lake with a short foot bridge so that anglers can access the lake more easily.

We have recently completed the outside loop of a mountain bike pump track on the north side of Clinton State Park (see photo). We'll add additional bumps and berms in the middle of the track in the coming weeks.

Melvern Lake

<u>Five Star Bike Trail at Eisenhower State Park:</u> The Eagle Loop (outer loop) was completed in August adding 4.1 miles to the existing hiking/biking trail. This brings the total trail length to just over six miles. Plans this winter are to complete three reroutes on Ike's loop (inter loop) and add

four more miles of trail along the lake heading south. The long range plans are to have about 14 miles of hiking/biking trails in the park.

<u>Melvern City Trail:</u> I've also been helping the City of Melvern with the design and construction of their River Park Trail. On April 19th we had a work day at the River Park Trail. There was a total of 1.6 miles of trail built in one day.



A total of 117 volunteers registered for the work day, donating over 900 hours of their time. Around 60 volunteers were from colleges around the state with the remainder being local citizens. The City plans to add an additional 4 miles of trails before next summer.

Perry Lake Bike Trails

Fall has arrived and things are looking great at the Perry Bike Trail. Concerns about trail damage and overgrowth from the unusual wet spring and summer were put to rest. The later half of the summer the trail stayed pretty dry. Several seeps that would not go away earlier were hardened with gravel to prevent them from turning into nasty mud bogs. The intent is to create a 3 to 5 mile all weather loop for competitions that would hold up in wet conditions and could be easily accessed for immediate repair.

The trail had its first test in September when Great Plains Running Company held an ultra runners race in wet conditions. With 5 inches of rain overnight and rain still falling in the morning the promoter and land manager agreed to keep the race on previously mentioned sections of the trail as a test to see if the hardening efforts would hold up and the trail held up great. Only a few soft spots were tracked up by the foot traffic, not much more than the deer cause after rain, and I expect those to roll out with regular wheel traffic in the next few weeks. If not those small areas will be addressed quickly and armored if necessary. We really do not promote the use of trails in wet conditions. There has been and will be more debate about holding competitions in wet conditions.

Smaller local events can be postponed or canceled but regional and national level events are often part of a series scheduled many months in advance with participants traveling from far away states and cannot be rescheduled. In these cases the promoters and land managers must agree to alter the route used to lessen negative impact and also work vigorously after the event to return the trail back to original or better condition. Great Plains Running Company and Heartland Sports Promotions have both stepped up and done the right thing is these cases at the Perry Bike Trail. We hope others will follow their lead.

Perry Lake Hiking Trails

Summer 2008 was a busy time for the Perry hiking trail. Two bridges were built by Boy Scouts to replace failed bridges. Our oldest bridge, built in 1997 near Old Military Trail campground, was replaced in June by Troops 177 and 69 of Topeka, KS (see photo on following page).

The 94th Street bridge (see photo below) that washed out a few years ago was replaced in August by Troop 7 of Topeka as an Eagle Scout project of Brett Sidesinger. Westar's Green Team provided the heavy wooden members and installation expertise.

Parts of Section 1 were mowed on September 20 through heavy lespedeza growth. On a frustrating note, trees were recently trimmed under a power line and a bunch of the debris was piled on the trail. Of course they probably couldn't have seen the trail as it may have been under three feet of lespedeza. We have a one-mower width trail in that area as we snaked through and around the debris.

An informational kiosk (see photo) was built on the trail at the Longview access road as an Eagle Scout project of Bobby Reagan.



All trail watchers are planning their autumn trail work, so expect more activity soon.

Smoky Valley Ranch

The Nature Conservancy requested assistance from the Kansas Trails Council to construct a public-use hiking trail on the privately-owned, 16,000-acre, Smoky Valley Ranch Preserve in western Kansas. Most of the ranch is leased for cattle and bison grazing, but the areas where trails are located have only cattle.



The Smoky Valley Ranch is among very few privatelyowned properties in Kansas to construct a public-access hiking trail. We designed and constructed two stacked loop public use trails, totaling six miles – a 1-mile loop and a 5mile loop with a common trailhead. Public access to the

trail is unlimited, but restricted to foot traffic only. Users are not allowed off the trail. A large area for off road parking at the trailhead will be available.

We also constructed a one-mile private use trail, which will be accessible to only guests of the ranch. Trails will have interpretive and navigational signage. Interpretative signs will include a variety of topics including Native American history, pioneer and ranching history, geology, wildlife, ecology and plant life. All trails are shared by cattle for five to six months each year and signage will be designed to be resistant to livestock. Combining livestock grazing on privately-owned rangeland with a public trail required special attention to issues not encountered in most public parks.

Wilson State Park Trails

Our use of glyphosate on the trail tread at Wilson was a great success. We will continue to use this technique to clear the tread of vegetation. The need for the chemical is because we don't have quite enough traffic to kill all the grass in the tread, and it is infeasible to do it by hand.

Wilson has seen near record amounts of rain this summer and the trail has held up very well, erosion-wise. We've actually had the lake water level within about 6" of inundating the tread at our lowest point on the trail. Doug Palen and I added about 1 mile of new trail, which will become part of the new beginners loop. Much of the Switchgrass trail is not rideable by inexperienced mountain bikers. I've scheduled a fall trail work weekend for 1-2 November, which will finish up surface work on the beginner loop and commence work on another new loop.
